

**2009 Santa Cash Giveaway
Official Contest Rules.. For Retail, Professional Businesses,
and Restaurant Businesses**

1. The winning ticket **must** be presented to win the \$5,000 or \$2,500 prize. The drawing will be held Saturday, December 19, 2009 at Will Rogers Downs Cherokee Casino at 1:00p. The **\$1,500 drawing (need not be present to win) 4** tickets will be drawn and one at any given time will be posted weekly or until a winning ticket is presented within deadlines on the Chamber website (www.claremore.org) and printed in the Claremore Daily Progress. Ticket must be presented for verification to the Claremore Chamber at 419 W. Will Rogers Blvd. by published deadlines.
2. The \$5,000 prize will be given away first, followed by the \$2,500 prize. There will be a time limit of 2 minutes after the winning ticket number is announced to claim the \$5,000 prize. If after 2 minutes the ticket matching the winning ticket drawn is not presented to the judges, another ticket will be drawn. The process will be repeated with a 1 minute time limit until there is a winner. The process will be repeated for the \$2,500 prize. The \$1,500 drawing as described in 1. Above. The five "Tinsel Tuesday" drawings will follow with a one minute time limit. Winner must be present to win.
3. One ticket will be given for every \$10 in purchases/services. EXAMPLE: A purchase of \$32.42 would get you (3) three tickets. See chart below.
